_____ 2. The owner certifies that the above dog or cat has received a flea treatment within the last two weeks. If we find your pet to have fleas we will ask the owner to remove their pet from the premises.

_____ 3. The owner understands that group play activities are only for spayed/neutered dogs or cats. The owner further understands that LED, Inc will not be held liable for accidental injury that could occur or result from group play, provided all policies and procedures were followed when the accident occurred.

_____ 4. No toys, blankets or other personal items are allowed into the event. Only a crate, collar and leash are permitted.

_____ 5. The owner understands that he/she is responsible for any damages that may be incurred as a result of the owner's pet harming another animal, person, or property of the event space.

_____ 6. The owner understands that in case of an emergency we will act on your behalf and utilize the services of The PSPCA, 350 Erie Avenue, Philadelphia, PA for all treatment. The owner further understands that he/she is responsible for all veterinary bills or service charges incurred.

_____ 7. The owner gives permission to LED, Inc to take photos or videos of their dog for any multi-media or print use. The owner hereby relinquishes all rights to the photos or videos and understands that he/she will not receive royalties or other compensation.

Waiver and Release

In consideration for being permitted to have my dog be a part of the Event (listed above), I hereby waive, release and discharge any and all claims for damages for personal injury, death or property damage which I may have hereafter accrue as a result of my dog's participation in said activity. This release is intended to discharge, in advance, Lotus Event Designs, Inc and all of their Associates (professionals and volunteers) used to perform the event from and against any and all liability arising out of or connected in any way with my dog's participation in said Event, even though that liability may arise out of negligence or carelessness on the part of Lotus Event Designs, Inc and all of their Associates (professional and volunteers).

This interaction can lead to aggressive or dominant behavior and may lead to the occurrence of stress or fighting between one or more participants in this area. Knowing the risks involved, nevertheless, I have voluntarily applied to have my dog participate in said Event, and I hereby agree to assume any and all risks of injury or death and to release and hold harmless Lotus Event Designs, Inc and all their Associates (professional and volunteers) who through negligence, carelessness or any other act or omission might otherwise be liable to me.

I further agree to indemnify and to hold Lotus Event Designs, Inc and all of their Associates (professionals and volunteers) free and harmless from any loss, liability, damage, cost or expense which they may incur as a result of any injury and/or property damage that I or my dog may sustain while participating in said Event.
